_____ I hereby enter a plea of **GUILTY** and waive appearance at trial. A Money Order/Cashier's Check, in the amount of the fine(s) is enclosed. Guilty Plea states that you are guilty of the charge against you.

_____ I hereby enter a plea of **NOLO CONTENDERE** and waive appearance at trial. A Money Order/Cashier's Check, in the amount of the fine(s) is enclosed. Nolo Contendere states that you do not contest the state's Charge(s) against you.

Failure to Make a Plea before the Court Appearance Date: The Court will issue a warrant for a violation of 'Promise to Appear, for each violation issued and will result in additional late fees added. The court may also deny renewal of your driver's License. (Due to Legislation updates, Fines and state fees are subject to change.)

DRIVING SAFETY COURSE (DSC)

YOU MAY BE ABLE TO HAVE SOME CHARGES DISMISSED BY TAKING A SIX HOUR STATE APPROVED DRIVING SAFETY COURSE. HOWEVER, YOU WILL LOSE THAT RIGHT IF YOU DO NOT ENTER A PLEA AND PAY THE FEE OF \$142.10 BEFORE THE COURT APPEARANCE DATE SHOWN ON THE CITATION.

***** IF YOU ARE A CDL HOLDER YOU ARE NOT ELIGIBLE FOR DSC OR DEFERRED DISPOSITION*****
YOU ARE NOT ELIGIBLE FOR DSC; IF YOU ILLEGALLY PASS A SCHOOL BUS; OR FOR A NON- MOVING VIOLATION. OR IF YOU HAVE TAKEN A DSC COURSE WITHIN THE PAST YEAR; IF YOU EXCEEDED THE SPEED LIMIT BY 25 MPH OR MORE OR GOING 95 MPH OR MORE; IF VIOLATION OCCURRED IN A CONSTRUCTION ZONE W/ WORKERS PRESENT

TO BE ELIGIBLE FOR A DRIVER SAFETY COURSE YOU MUST BE A TEXAS RESIDENT. INCLUDED A COPY OF YOUR VALID TEXAS DRIVERS LICENSE; A VALID COPY OF LIABILITY INSURANCE ; A COPY OF THE CITATION; IT WILL BE YOUR RESPONSIBILITY TO COMPLETE THE COURSE WITHIN 90 DAYS FROM DATE OF YOUR COURT APPEARANCE, NO EXTENTIONS ARE ALLOWED FOR DSC. YOU MUST PROVIDE A DRIVING RECORD TO THE COURT, ORDER FORM TYPE 3A AND SUBMIT TO COURT WITHIN 90 DAYS.
