After the herein described estray was impounded, I made a diligent search of the register of the recorded brands in the county where said estray was found. The search did not reveal the owner of the said estray.

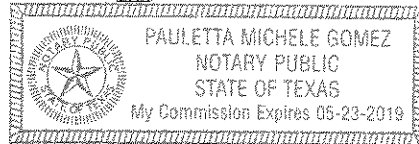
I did then advertise the impoundment of the said estray on Bee County's Website for at least 15 days after the impoundment of the said estray.
