COVID-19 PERIODIC UPDATE

December 2, 2020

Greetings from the offices of the Bee County Judge and the Mayor of the City of Beeville. In an effort to reduce the length of this update, we have removed information on previous daily updates. Please know that you can access the full text of all prior daily updates on our Bee OEM Facebook page.

TXDSHS has modified its reporting to Counties. Now we only receive the number of new cases, no detailed information such as sex or age range of affected parties.

CASE UPDATE

Total Bee County confirmed community cases (i.e. <u>not</u> TDCJ inmates): 1,485

Total new cases reported today: 95

On November 19, 2020, DSHS notified Bee County of 7 additional community cases. On November 20, 2020, DSHS notified Bee County of 1 additional community cases. On November 21, 2020, DSHS notified Bee County of 6 additional community cases. On November 23, 2020, DSHS notified Bee County of 15 additional community cases. On November 24, 2020, DSHS notified Bee County of 7 additional community cases. On November 25, 2020, DSHS notified Bee County of 8 additional community cases. On November 27, 2020, DSHS notified Bee County of 9 additional community cases. On November 28, 2020, DSHS notified Bee County of 8 additional community cases. On November 30, 2020, DSHS notified Bee County of 13 additional community cases.

No new cases were reported on November 22, 26 and 29 and, so far, on December 1 or 2.

Also, on the following dates DSHS notified Bee County of additional cases which are <u>not new cases</u> but are cases that were found in a backlog of old cases: Nov. 21 – 41 cases; Nov. 24 – 1 new case; Nov. 28 – 2 new cases; and Nov. 30 – 6 new cases.

DSHS DASHBOARD SUMMARY

As of 4:30 p.m. today, December 2, 2020, according to the Texas Department of State Health Services ("DSHS") Dashboard, Bee County currently has

102 active cases;

1,914 recovered cases; and

2,056 total cases (non-prisoner and prisoner) since tracking began.

The Dashboard also reflects 40 fatalities in Bee County.
